RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION FOR ILEX GROUP, INC. NORTHEAST GATEWAY 1 URBAN RENEWAL PROJECT

WHEREAS, on June 28, 2021, by Roll Call No. 21-0983, the City Council approved an Urban Renewal Agreement ("Development Agreement") between the City and ILEX Group, Inc. and JE Northridge 2021, LLC (collectively "Developer") for the construction of two warehouse buildings located upon the Property in the vicinity of 4600 NE 14th Street ("Improvements"); and

WHEREAS, the terms of the Development Agreement provide that the City shall issue the Certificate of Completion upon the City's determination of satisfactory completion of the Improvements and the Developer has requested that the Certificate of Completion for the project be issued; and

WHEREAS, City staff has inspected the Improvements and found the Improvements have been completed in substantial compliance with the terms of the Development Agreement and approved construction plans; and

- 1. The City Council hereby finds and acknowledges that Developer has satisfied its obligation to construct the Improvements on the Property in substantial compliance with the provisions of the Development Agreement and the approved construction plans.
- 2. This Resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.4 of the Development Agreement.
- 3. The City Clerk is hereby directed to cause a certified copy of this resolution and roll call to be delivered to the City's Office of Economic Development, and the Office of Economic Development is directed to cause the certified copy to be delivered to the Developer for recording.
