RESOLUTION AUTHORIZING RELEASE OF SPECIAL ASSESSMENTS AND PARTIAL RELEASES OF JUDGMENT LIENS FOR CERTAIN PROPERTIES ACQUIRED THROUGH THE TAX SALE CERTIFICATE PROCESS

WHEREAS, Iowa Code Section 446.19A permits cities to acquire tax sale certificates for abandoned property assessed as residential property or as commercial multifamily property or vacant residential lots at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the certificate holder the amount then due to redeem the certificate, and to further assign said certificates, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings and lots; and

WHEREAS, on June 3, 2019, by Roll Call No. 19-0892, the City Council approved acquisition of the tax sale certificate for the vacant and abandoned property locally known as 801 Shaw Street, 409 E Granger Avenue, and 2811 Payne Avenue, Des Moines, Iowa ("Property"), entered into a development agreement with Neighborhood Finance Corporation (NFC) and begin the process to take tax sale deed; and

WHEREAS, on December 29, 2022 the City of Des Moines requested and was issued the tax sale deeds for the Property by the Polk County Treasurer; and


WHEREAS, the special assessments against the Property have been identified by NFC as an encumbrance to redevelopment for housing; and

WHEREAS, the City had filed lawsuits and obtained judgments against the owners of the above properties in relation to nuisance abatement and enforcement costs, court costs and sanctions, which liens encumber the real property; and

WHEREAS, City staff has reviewed these judgment liens and determined that it is in the City's best interest to release the judgment liens against the property in order to encourage redevelopment of the sites.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. All special assessments levied by the City and pending against the Property shall be deemed released. This shall include assessments listed below and any other City of Des Moines special assessments incurred by the property and tracked by the Polk County Treasurer's Office prior to the date of this roll call.


