APPROVING \$50,000.00 OF ADDITIONAL FUNDS FOR THE PROCUREMENT OF FLYGT PUMP REPAIR PARTS AND SERVICES AT STORM AND SANITARY PUMP STATIONS FROM ELECTRIC PUMP & TOOL SERVICES, INC. AT A TOTAL ESTIMATED ANNUAL AMOUNT OF \$125,000.00

WHEREAS, the Sewers Division of the Public Works Department previously requested the Finance Department, Procurement Division to issue blanket purchase orders for Flygt pump repair parts and services for all storm and sanitary pump stations to be purchased during fiscal year 2023; and

WHEREAS, the Procurement Administrator determined that the requested repair parts and services for all storm and sanitary pump stations were available from Electric Pump & Tool Services, Inc. 4280 E 14th Street, Des Moines, IA 50313, Tom Miller, President, the sole area-wide distributor; and

WHEREAS, Roll Call 22-1027, dated June 27, 2022, approved the purchase of Flygt pump repair parts and services from Electric Pump & Tool Services, the sole area-wide distributor, and authorized expenditures at an annual estimated amount of \$75,000.00 from PW247412, Sanitary Sewer Operations Fund, and PW247414, Stormwater Utility Operations Fund; and

WHEREAS, additional spending in the amount of \$50,000.00 is anticipated for the remainder of fiscal year 2023 for the purchase of Flygt Pump repair parts and services; and

WHEREAS, \$50,000.00 of additional funding is available from PW247412, Sanitary Sewer Operations Fund, and PW247414, Stormwater Utility Operations Fund.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$50,000.00 for the purchase of Flygt pump repair parts and services from Electric Pump & Tool Services, Inc. for the remainder of fiscal year 2023, at a total estimated annual amount of \$125,000.00 for use by the Public Works Department as described above, is hereby approved.
