**APPROVING \$200,000.00 OF ADDITIONAL FUNDS FOR THE ANNUAL AGREEMENT WITH STEW HANSEN DODGE CITY TO PROVIDE AUTO BODY REPAIR SERVICES TO BE USED BY CITY DEPARTMENTS FOR A TOTAL ESTIMATED ANNUAL AMOUNT OF \$350,000.00**

WHEREAS, the Fleet Services Division requested the Finance Department, Procurement Division secure a provider of Auto Body Services for use by City Departments for Fiscal Year 2023; and

WHEREAS, Municipal Codes section 2-726 (k) provides for the procurement of goods and/or services from supply schedules established by the State of Iowa Department of Administrative Services (DAS), without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the Fleet Services Division entered into an annual agreement for autobody repair services, utilizing the State of Iowa (DAS) purchasing contract number 22044, with Stew Hansen Dodge City (GL Dodge City LLC, 12103 Hickman Road, Des Moines, IA 50323, Dan Boettcher, General Manager) with four (4) additional one-year renewal options at an estimated annual total of \$150,000.00; and

WHEREAS, additional spending in the amount of \$200,000.00 is anticipated for the remainder of fiscal year 2023 due to an increase in autobody repair services; and

WHEREAS, the requested additional funding of \$200,000.00 is available from Fiscal Year 2023 Operating Budget, Fleet Services Maintenance, 1010 FN024020, Equipment Maintenance Center Fund, page 76.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$200,000.00 annually for the remainder of fiscal year 2023 at a total estimated annual amount of \$350,000.00 for Auto Body Repair Services to be paid per agreement with Stew Hansen Dodge City (GL Dodge City LLC) for use by the City Departments as described above, is hereby approved; and the Finance Department is authorized to approve the renewal(s) of the agreement as provided therein, with price increases complying with the agreement terms.
