RESOLUTION APPROVING \$100,000.00 OF ADDITIONAL FUNDS FOR THE ANNUAL AGREEMENT WITH STONE CROSS LAWN & LANDSCAPE LLC FOR SIDEWALK SNOW REMOVAL SERVICES TO BE USED BY THE PUBLIC WORKS DEPARTMENT, FOR A TOTAL ESTIMATED ANNUAL AMOUNT OF \$400,000.00

WHEREAS, the Public Works Department requested the Finance Department, Procurement Division to solicit bids for an annual agreement with four (4) additional one-year renewal options to furnish Sidewalk Snow Removal Services; and

WHEREAS, the Procurement Division solicited bids by advertisement and emailing Request for Bid N21-71 to twenty five potential bidders with two (2) compliant bids received; and

WHEREAS, on November 23, 2020, by Roll Call #20-1914, the City Council approved an award to Stone Cross Lawn & Landscape LLC, 3968 NW Urbandale Dr., Urbandale, IA 50322, (Brad Puckett, Owner) and authorized expenditures at an annual estimated amount of \$300,000.00 from Various Operating Budgets; and

WHEREAS, additional spending in the amount of \$100,000.00 is anticipated for the remainder of fiscal year 2023 as the City added 3.2 miles of protected bike lanes encompassed within various streetscapes throughout the City, and due to a lack of snow storage on these streetscapes, each storm event resulted in loading and hauling the snow from these areas; and

WHEREAS, \$100,000.00 of additional funding is available from 2022-2023 Operating Budget, Public Works Department, Street Maintenance S360, PW240402 page 225.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the additional expenditure of \$100,000.00, with a total estimated annual amount of \$400,000.00 for Sidewalk Snow Removal Service to be paid per agreement with Stone Cross Lawn & Landscape LLC for use by the Public Works Department as described above, is hereby approved.
