BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$304,213.75, executed by MPS Engineers, P.C. dba Kingston Services, P.C., Umesh G. Shetye, President, 1444 Illinois Street, Des Moines, IA, 50314 dated February 20, 2023, for the construction of the following improvement:

Pennsylvania Avenue Rehabilitation from E. Washington to E. Jefferson, 062023004

The improvements includes Portland Cement Concrete (PCC) curb and gutter, milling 2-inch Hot Mix Asphalt (HMA) paving, PCC trail, PCC driveways, earthwork and grading, pavement markings, water services, erosion control, restoration, and other incidental items; all in accordance with the contract documents, including Plan File No. 648-218/246, located along Pennsylvania Avenue from E. Washington Avenue to E. Jefferson Avenue, Des Moines, Iowa

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved, subject to receipt of the contract and bond approved as to form by the Legal Department, and certificate of insurance acceptable to the Engineering Departments.

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract and bond approved as to form by the Legal Department, and certificate of insurance acceptable to the Engineering Department, and the City Clerk, be and is hereby authorized and directed to attest to same. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security in accordance with the Instructions to Bidders.
