WHEREAS, on March 27, 2023 by Roll Call Nos. 23-0631 and 23-0362, the Municipal Housing Governing Board set the public hearings to consider the Municipal Housing Agency's amended annual budget for all projects for the current fiscal year ending June 30, 2023 and to consider the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2024, for April 10, 2023 and public notice of such hearings was published as provided by law; and

WHEREAS, following the respective public hearings on April 10, 2023, the Municipal Housing Governing Board approved the Municipal Housing Agency's amendment to annual budget for all projects for the current fiscal year ending June 30, 2023, by Roll Call No. 23-0459 and approved the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2024 by Roll Call No. 23-0460 and

WHEREAS, the Des Moines Municipal Housing Agency is required to certify approval of the operating budgets to the U.S. Department of Housing and Urban Development.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that the Mayor and City Clerk, as appropriate, are hereby authorized and directed to certify the Municipal Housing Agency's amended annual budget for all projects for the fiscal year ending June 30, 2023 and to certify the Municipal Housing Agency's proposed budget for all projects for the fiscal year ending June 30, 2024 on the forms on file in the Office of the City Clerk and the Neighborhood Services Director is hereby directed to submit such certifications to the U.S. Department of Housing and Urban Development.
