**APPROVING ARPA FUNDING AGREEMENT WITH BRAVO GREATER DES MOINES FOR GENERAL OPERATIONS**

WHEREAS, on March 11, 2021, Congress enacted the American Rescue Plan Act of 2021 (“ARPA”) to provide relief to combat the continued impact of COVID-19 on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, the City has received ARPA funding from the Coronavirus State and Local Fiscal Recovery Funds and the City desires to aid nonprofit organizations to address the disparate inequities that impacted the Des Moines community; and

WHEREAS, Bravo Greater Des Moines (“Agency”) seeks funds for the general operations of the Agency and consistent with the purposes set forth within the existing 28E agreement with the City and will specifically focus on: 1) teacher training in arts integration to build long-term capacity of educators to leverage arts and culture to enhance learning outcomes and strengthen student engagement, 2) expanding after school and summer arts and cultural engagement opportunities and access, and 3) capacity building to sustainably strengthen organizations’ ability to provide quality and vibrant youth arts programming (“Project”); and

WHEREAS, the Agency will endeavor to maximize the impact of existing programs being delivered by cultural organizations headquartered in and already in partnership with the Agency, including the following collaborators:

WHEREAS, the Project will prioritize programming impacting Des Moines residents under the age of 18; and

WHEREAS, the Project will serve the public purposes of cultivating arts and culture within the City of Des Moines; and

WHEREAS, the City desires to enter in to a ARPA Funding Agreement (“Agreement”) to provide a financial grant in the amount of \$750,000 in support of the Project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The Finance Director is hereby authorized and directed to expend ARPA federal funds received by the City from the U.S. Department of Treasury, OMB Number 1505-0271, titled Corona Virus Local Fiscal Recover Fund, in an amount not to exceed \$750,000 in accordance with the terms of the Agreement.
2. The Grant Agreement between the City and Agency for the Project for a grant not to exceed \$750,000 is hereby approved and, subject to the Legal Department’s approval of the Agreement as to form, the Mayor is hereby authorized and directed to sign said Agreement, and the City Clerk is hereby authorized and directed to attest to the Mayor’s signature.
