APPROVING PROCUREMENT TO PURCHASE AND INSTALL VARIOUS TRUCK BODY EQUIPMENT AND ACCESSORIES ON SIX (6) CITY-OWNED CHASSIS IN THE TOTAL ESTIMATED AMOUNT OF \$370,737.00

WHEREAS, the Fleet Services Division requested the Finance Department, Procurement Division to solicit bids for the purchase and install of various truck body equipment on six (6) city-owned chassis; and

WHEREAS, the Procurement Division solicited bids by email and advertisement on the City's electronic procurement platform through Request for Bid #K23-426 to potential bidders, with one (1) compliant bid received; and

WHEREAS, the lowest responsible bid for the purchase and install of various truck body equipment on six (6) city-owned chassis was received from Truck Equipment Company, (1560 NE 44th Avenue, Des Moines, IA 50313, Terry Wieseler, Owner); and

WHEREAS, funding for said procurement is available from Equipment Replacement Fund FY2023-2024 Operating Budget, page 79, for an estimated cost of \$370,737.00; and

WHEREAS, the Procurement Administrator and Department of Public Works recommend approval of the lowest responsible bid to the purchase and install of various truck body equipment on six (6) city-owned chassis, subject to the terms and conditions set forth in Request for Bid # K23-426.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, hereby accepts and approves the aforementioned lowest responsible bid from Truck Equipment Company for the above-described purchase and install of various truck body equipment on six (6) city-owned chassis at an estimated total amount of \$370,737.00; the Finance Department, Procurement Division is hereby authorized and directed to issue a purchase order for said services and at said estimated total cost pursuant to the terms and conditions of Request for Bid #K23-426.
