**APPROVAL OF RENEWAL REQUEST FOR EXTENSION OF THE DESIGNATED HOUSING ALLOCATION PLAN**

**WHEREAS**, the City of Des Moines Municipal Housing Agency (DMMHA) may adopt a Designated Housing Allocation Plan identifying units for occupancy by elderly and near elderly families pursuant to 24 CFR Part 945; and

**WHEREAS**, the Municipal Housing Governing Board first approved submission of a Designated Housing Allocation Plan designating four of the Public Housing Manors as housing for occupancy by elderly and near elderly persons to the U.S. Department of Housing and Urban Development (HUD) on January 8, 2001; and

**WHEREAS**, the Municipal Housing Governing Board approved two-year extensions of this Designated Housing Plan on December 19, 2005, December 17, 2007, November 23, 2009, January 23, 2012, December 9, 2013, December 21, 2015, December 4, 2017, February 24, 2020, and December 20, 2021; and

**WHEREAS**, the City of Des Moines Municipal Housing Agency is submitting another request to HUD to extend the Designated Housing Allocation Plan for an additional two years.

**NOW, THEREFORE, BE IT RESOLVED**, by the Municipal Housing Governing Board of the City of Des Moines, Iowa, that the renewal request for a two-year extension of the Des Moines Municipal Housing Agency's Designated Housing Allocation Plan is hereby approved, and the City Manager or his designee is hereby authorized to submit the renewal request to the U.S. Department of Housing and Urban Development.
