RESOLUTION APPROVING THE PURCHASE OF REPLACEMENT SNOW AND ICE CONTROL EQUIPMENT FROM HENDERSON PRODUCTS INC.

WHEREAS, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for replacement snow and ice control equipment for use by the Street Maintenance Division of the Department of Public Works; and

WHEREAS, the Procurement Administrator has determined that the replacement snow and ice control equipment has been competitively bid and is available from Henderson Products Inc. (916 South 10th Street, Manchester, IA 52057, John Sievert, President), using Sourcewell Contract Number 080818-HPI; and

WHEREAS, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

WHEREAS, the replacement snow and ice control equipment is being purchased from Henderson Products Inc., in the amount of \$272,442.00 utilizing the Sourcewell Contract Number 080818-HPI; and

WHEREAS, funding is available from Fiscal Year (FY) 2023-2024 Operating Budget, Equipment Replacement Fund, Page 80.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Des Moines, Iowa, hereby accepts and approves the purchase of replacement snow and ice control equipment for use by the Street Maintenance Division of the Department of Public Works from Henderson Products Inc., in the amount of \$272,442.00 utilizing the Sourcewell Contract Number 080818-HPI.


