APPROVING STANTON RIDGE FINAL PLAT AND ACCEPTANCE OF SUBDIVISION BOND

WHEREAS, the final subdivision plat entitled Stanton Ridge, for property located in the vicinity of 2300 Stanton Avenue, to be developed by KEC Investments, LLC, 4817 Fleur Drive, Des Moines, Iowa, Ryan Winter, authorized agent, was submitted to the Development Services Department on November 8, 2023; and,

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on July 7, 2022; and,

WHEREAS, subject to the conditions identified below, the said subdivision plat conforms to Iowa Code Sections 355.8, 354.6, and 354.11, and said subdivision plat conforms to the standards and conditions set forth in Chapter 106 of the Municipal Code of the City of Des Moines, Iowa; and,

WHEREAS, the City Engineer has approved the amount of the security for subdivision improvements.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
2. Subdivision bond number 100309037 from Merchants Bonding Company, in the amount of \$155,100.00 is hereby accepted and approved as adequate public security for the completion of the required public improvements including public sidewalk within the plat.
3. Upon satisfaction of the conditions set forth above, the Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate.
4. The City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Developer for delivery to the County Recorder for recording by the plat proprietors. The City Clerk is hereby further directed to send a copy of the subdivision plat to the Board of Education, Century Link Communications, Mid-American Energy, Mediacom, Des Moines Water Works, U.S. Post Office – Post Master, U.S. Post Office – Technical Sales
