**RESOLUTION APPROVING THE PURCHASE OF ONE (1)  
ADDITIONAL ASPHALT RECYCLER FROM  
K M INTERNATIONAL, AND APPROVING THE USE OF  
SOURCEWELL CONTRACT NUMBER 080521-KMI**

**WHEREAS**, the Fleet Services Division has requested the Finance Department's Procurement Division to issue a purchase order for an additional asphalt recycler for use by the Street Maintenance Division of the Department of Public Works; and

**WHEREAS**, the Procurement Administrator has determined that the replacement tracked excavator has been competitively bid and is available from K M International, 6561 Bernie Kohler Dr, North Branch, MI 48461, (Suong Rho, CEO), using Sourcewell Contract Number 080821-KMI; and

**WHEREAS**, Des Moines Municipal Code section 2-726 (m) provides for the procurement of goods and/or services from contracts that have been competitively established through cooperative group contracting consortiums for state government departments, institutions, agencies and political subdivisions, without conforming to the competitive bidding requirements of the Procurement Ordinance; and

**WHEREAS**, the replacement tracked excavator is being purchased from K M International in the amount of \$101,365.00 utilizing the Sourcewell Contract Number 080521-KMI; and

**WHEREAS**, funding is available from 2023-2024 Operating Budget, Equipment Replacement Fund, Page 80.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Des Moines, Iowa, that:

1. The purchase of an additional asphalt recycler for use by the Street Maintenance Division from K M International, in the amount of \$101,365.00 utilizing the Sourcewell Contract Number 080521-KMI is hereby approved.
2. To the extent determined necessary by the Legal Department and the Finance Department, the Finance Department and Fleet Division are hereby authorized and directed to proceed with negotiation of a Short Form Agreement or similar agreement between the City of Des Moines and K M International, supplementing Sourcewell Contract Number 080521-KMI, and the Finance Director is authorized and directed to execute said Agreement on behalf of the City following approval as to form by the Legal Department.
